# Objectives of the workshop

The Young Professionals Forum on EU diplomacy is organised by the University of Pisa in the context of the project EUDIPLO (2020-2023), "The European Union in International diplomatic relations". The workshop is especially directed to diplomatic trainees, graduate and post graduate students interested in a career as civil servants within the diplomacy machinery of the EU and its Member States.

We invited 12 early career professionals such as former Junior Professionals in Delegation (JPD) and/or former trainees who work (or have worked) at the EU delegations. The young professionals will present their experience at the EU delegations located in different regions of the world.

We are particularly interested in giving visibility to the work that is carried out by the EU delegations in the world. Indeed, the EU delegations are less known than national Embassies. The workshop is intended to present the work that is carried out at the EU delegations to explain the diplomatic possibilities and challenges to those interested in a career in diplomacy.

Both the European External Action Service and the Union delegations – and hence the European Union's diplomatic institutional machinery – remain largely unknown to the public. Yet, the European Union not only has a worldwide network of more than 140 'embassies', but at the same time it has assumed 'state-like' functions on the basis of the adoption of diplomatic rules that were originally created for states only. Many challenges do remain, but the deep and

wide legal and policy powers – and the sheer size and universal network – of the European Union also offer opportunities that remain as of yet untapped.

Academic and policy analyses have pointed to a great number of legal and political questions related to the developing role of the EU in international diplomacy. The Network EUDIPLO focuses on this central question: What are the internal and external constraints and opportunities for the European Union to further its ambitions as an international diplomatic actor? In dealing with this question, the Network aims to generate a stronger awareness on, and contribute to deeper insights with regard to, the European Union's diplomatic activities throughout the world, in third States as well as at multilateral fora.

# **Short bios of speakers**

#### **Keynote Speakers**

Mariomassimo Santoro is Head of Division for Policy Coordination in the European External Action Service since April 2021. Before holding this position, he was First Counsellor at the Permanent Representation of Italy to the European Union, Antici Counsellor and Chief policy coordinator (2017-2021). He has worked for the Ministry of Foreign Affairs as the Head of Unit for "Human Rights, Humanitarian International Law and Council of Europe" (2015-2017) and for the Permanent Representation of Italy to the European Union. Previously, he has held a position in the Ministry of Foreign Affairs: Directorate General for European Integration - CFSP/CSDP Unit (2009-2010). He has been Political Adviser to the European Union Special Representative (EUSR) for the crisis in Georgia (2008-2009) and Deputy Head of Mission at the Italian Embassy in Minsk, Belarus (2005-2008). He joined the Italian Ministry of Foreign Affairs in 2003.

Jurgis Vilčinskas is Deputy Head of Strategic Communications and Information Analysis Division in the European External Action Service. Prior to joining EEAS, Jurgis has served at Lithuania's diplomatic service and on President Valdas Adamkus team as a speechwriter on foreign policy issues and advisor on the EU affairs. He is alumni of Vilnius and Oxford Universities and a researcher at Oslo and Creighton Universities, with professional trainings in IMF Institute (Washington, D.C.) and Clingendael Institute of International affairs in The Hague. Jurgis overseas postings included secondments to the Royal Danish Ministry of Foreign Affairs and for the European External Action Service - two diplomatic posts in Sarajevo and Kyiv, where he respectively headed Political, Trade, EU, and Communications Sections. He was a speaker at Krynica Economic Forum, Davos Communication Forum, Wilton Park, and other events dedicated to media and public diplomacy issues in the EU's Eastern Neighbourhood. Jurgis is a co-founder of the EU affairs experts' network and led diverse media and EU affairs projects.

#### Panel 1

Edvardas Aleksandras holds a Bachelor in Business and Linguistics from Trinity College Dublin, a Master in Advanced International Studies from the Diplomatic Academy of Vienna and an M.A. in Social Science from the Trinity College Dublin. He first worked as Junior Market Advisor for the Embassy of Ireland to the Russian Federation (2010), then as Intern (Military Attaché) at the Permanent Mission of Ireland to the OSCE in Vienna (2013). Still in Vienna, he was Policy Analyst at the Permanent Mission of Afghanistan to the International Organisations (2013-2014). In 2014, he took up a Blue Book Trainee position for the European Commission (Western Europe/EEA Division); he was also Economic Advisor on migration (STA) at the Office of the Coordinator for Economic and Environmental Activities (OSCE) and Election Observer during the 2016 Duma Elections in Russia. Subsequently, Edvardas became Junior Professional (Attaché), working in the Political Section of the EU Delegation to Russia (2016-2017). Then, he took up the position of Political Assistant (Intérimaire) for the European Commission (2017-2018). At present and since 2019, he works as Political Officer for the EEAS in the EU Delegation to the Republic of Kazakhstan.

Wioleta Stasieluk holds an MA in International Security from Sciences Po Paris, and a BA in International Relations and Swahili from the School of Oriental and African Studies, University of London. With her experiences in East Africa and fluency in Swahili, she returned to the region as a trainee in the Political, Press and Information Section at the EU Delegation to Kenya. She worked as a teaching assistant and careers assistant at Sciences Po (2018-2020) before taking up an internship at the UNODC Regional Office for Southern Africa in the Drug Prevention and Health Branch. She is currently working as a Junior Policy Analyst at the Crises & Fragility Team at the OECD.

Ellen Flanagan holds a Bachelor of Law & French from University College Cork (Ireland), where she was awarded the Quercus University Scholarship for Academic Excellence. She graduated with an M.A. in EU International Relations & Diplomacy from the College of Europe in 2018 and took up a position as a Graduate Policy Officer in the Brexit Unit of the Irish Permanent Representation to the EU. In 2019, she became Junior Professional in the EU Delegation to Malaysia, where she worked in the political section. Since 2021, he's working as Trade Policy Advisor for the Israel Mission to the EU in Brussels.

She has over four years of professional experience working in complex, politically dynamic environments for EU, UN, and Government agencies.
